Gold Management Procedure

Summary

This procedure describes how **K's Jewellery & Co.** is tracking the gold for the provenance claim about non-conflict gold and that the jewelry complies with the requirements of the Dodd Frank Act for Conflict Free Gold

1. Objective

The goal of this procedure is to ensure that the gold is tracked through the company from procurement to Jewellery dispatch and there is no mix up in non-conflict gold with any other gold.

2. Principle

Conflict-Free Gold

Products are considered "conflict-free" under Dodd-Frank Act and SRSP if they do not contain minerals that directly or indirectly finance or benefit armed groups in the "covered countries:" the Democratic Republic of the Congo, Angola, Burundi, Central African Republic, the Republic of the Congo, Rwanda, South Sudan, Tanzania, Uganda, and Zambia.

3. Purpose

To ensure that the gold used in the jewelry is conflict-free / complies to Dodd Fran Act and it is Conflict-Free.

4. Documents

Dodd Frank Act

5.0 Procedure

The procedure for tracking and managing gold and jewellery through the company's manufacture and refining processes.

5.1 Gold

The gold bars are procured from Banks & RBI Nominated Agency for supply of Gold to Manufactures ie. Diamond India Limited. At the time of purchase, it should be ensured that the gold Bullion is from a Refinery that is on the LBMA Good Delivery list. Obtain a certificate from the Bank selling the Gold Bullion that the gold is conflict free.

5.2 Gold Control

The gold control shall receive the gold from the bank and record the stocks. The records of the gold issued and received from different departments like Casting, Production and Refiners shall be maintained to ensure that the quantity of the gold on system and the physical quantity always Tallies

5.3 Casting

The casting department shall give the gold account to the gold control for the conflict free gold received and the addition of alloys as well as the casting, sprue and the dust weight. Casting department shall not add any other gold from any other source.

5.4 Production

The production department must ensure that they use the gold castings and other gold wires etc. that are supplied by the Gold Control. No outside gold shall be used in the production process

5.5 Solder and Wires

All the solder and wires shall be drawn from the non-conflict gold and it shall be recorded in the gold control.

5.6 Findings

All the findings procured shall be from conflict free gold and the Purchase Invoice shall bear the declaration of Conflict-Free Gold as required by Dodd Frank Act

5.7 Refinery

All the gold dust received by the refinery shall be recorded and the gold after refining the dust shall be returned to Gold Control. The alloys, sprue and rejected castings received for refining shall be returned to Gold Control. No gold from any other source shall be taken and mixed during the refining.

5.8 Sale of Jewelry

The jewellery sold by the company shall be made from conflict-free gold as per this procedure and the gold tracking through the factory. The sales invoice shall have the provenance claim declaration of Conflict-free gold

5.9 General Conditions

All the gold used in the manufacturing process is from Banks only. SEEPZ is a Controlled area and no other gold from any other source is mixed in the Gold Bullion that is received from Banks and is Conflict-free.

5.10 Statement on Provenance Claim

- To our best knowledge, and/or written assurance from our suppliers, The Seller states that diamonds have not been obtained in violation and / or sanctions by the US departments of Treasuries office of foreign assets control (OFAC) and have not been originated from the MBADA and Marange resources of Zimbabwe.
- To the Best of our knowledge and / or written assurance from our suppliers, we state that Diamonds are in compliance with the relevant WFDB charter. The Seller has synthetic diamond testing technology and all the diamonds are checked in the testing machines for the surety of natural diamonds.
